Important Deadline: your personal information

If you have not already returned a signed copy of the Information Consent Form that was included with your licence renewal package, note that July 1, 2005 is the cutoff deadline for transferring your personal contact information to the BC Dental Association (BCDA) or to the Certified Dental Assistants of BC (CDABC). The original form for dentists was printed on yellow paper, and for CDAs it was printed on pink.

If you use your home or other personal information as your mailing address for the College, we require your consent, under the *Freedom of Information and Protection of Privacy Act*, to release this information. If we do not have consent, then we will no longer forward your contact information to the appropriate association. If, however, a dentist uses their practice address as their mailing address, it will automatically be provided to the BCDA unless the dentist specifies otherwise.
