Completed renewal forms and payment must be received at CDSBC **no later than March 1, 2011**. Dentists and CDAs who have not renewed by March 1 are not permitted to practice until they are reinstated. New this year, CDSBC now offers the option of paying via Interac at the CDSBC office.

## Have You Met Your CE Requirements?

All dentists and CDAs whose CE cycles ended on December 31, 2010 must have met their CE requirements to be eligible for practising renewal in 2011–12. CDSBC has processed all submissions received to date for those CE cycles that ended in 2010. Our records show that approximately 35 dentists and 155 CDAs have not yet met these requirements. **Dr. Allan Rose**

Notice of the following Interim Suspension Order is provided in accordance with section 39.3 of the *Health Professions Act*.

On May 18, 2010, a Panel of the Inquiry Committee of the College of Dental Surgeons of British Columbia (“CDSBC”) issued an Order under section 35(1) of the *Health Professions Act* suspending the registration of Dr. Allan Rose, on an interim basis during the investigation of certain matters relating to Dr. Rose’s practice of dentistry. The Committee is concerned that Dr. Rose may suffer from a physical or mental ailment that could affect his ability to practise dentistry.

While the registration of Dr. Rose is under suspension, he is prohibited under the CDSBC Bylaws from engaging in the practice of dentistry. Dr. Rose’s practice is located at 240 - 522 - 7th Street, New Westminster, BC.

**Dr. Clarence Stelmaschuk**

Notice of the following Interim Suspension Order is provided in accordance with section 39.3 of the *Health Professions Act*.

In order to protect the public, and pursuant to section 35 of the *Health Professions Act*, the CDSBC Inquiry Committee has suspended the registration of Dr. Clarence (Clark) Stelmaschuk pending a hearing of the Discipline Committee. This suspension is effective February 5<sup>th</sup>, 2011, in accordance with the *Health Professions Act*.

While the registration of Dr. Stelmaschuk is under suspension, he is prohibited under the CDSBC Bylaws from engaging in the practice of dentistry. Dr. Stelmaschuk’s practice is located at 2 - 2757 Bourquin Crescent West, Abbotsford, BC.
