NEW: Minimal and Moderate Sedation Services in Dentistry Standards & Guidelines

This document contains significant changes and must be read by all registrants who provide minimal or moderate sedation. Most of the requirements take effect immediately, while others will be phased in. You can read a summary of the requirements and access the new standards at www.cdsbc.org/sedation. This document replaces the previous *Minimal and Moderate Sedation Services Guidelines*.
